New 'catch-up' collections will benefit residents in severe weather

ollowing a recent public weekly consultation - and an extensive review of our previous procedures strateg:

- Cotswold District Council has introduced several measures for disp to reduce the possible delays in fortnightly refuse collections when severe

collections when severe weather takes hold over a prolonged period.

When it is not possible to collect waste on the scheduled collection day or the

following day, our waste collector (Ubico Ltd) will now operate kerbside catch-ups for refuse the following week (weather permitting) rather than residents having to wait for a further 14 days until their next scheduled kerbside collection.

When this catch-up option is activated, Ubico will suspend weekly garden waste collections temporarily, and will, instead, pick up refuse, along with the usual weekly food waste collections.

Ubico will also make full use of emergency waste collection points at strategic locations across the district so that residents can bring refuse for disposal if necessary. Subject to safety and access considerations,

> locations in Bourton, Cirencester, Fairford, Lechlade, Moreton, Northleach, Stow and Tetbury have been earmarked for this purpose. Residents will also have the

option of taking all their waste to Household Recycling Centres across the county - including the nearby facility at Fosse Cross.

The Ubico crews will operate priority catch-up collections in some locations served by communal bins. They will also, on request, pick up waste from residents who already have an arrangement for an assisted collection with the Council and do not have sufficient space to store excess waste - provided the crews



can access their properties safely. This will benefit those who, due to their age or disability, would find it difficult to access emergency collection points. However, there will be no extra collections of missed recyclables.

HEAVY SNOW, ICE AND FLOODING

What should you do if your refuse collection is disrupted during severe weather?

Don't assume that you have been missed if the Ubico crew is late - leave your waste out all day because they will continue to try collecting in the most accessible parts of your area rather than imposing a blanket cancellation for the day's round.

IF NO SHOW ON COLLECTION DAY

Leave your refuse at kerbside, for collection the following day. Check the Council's website or local media updates.

IF NO SHOW ON FOLLOWING DAY

Take refuse back to your property and present for collection again on next weekly food waste collection day.

NEXT FOOD WASTE COLLECTION

Crews will attempt general AND food waste pick up. Weekly garden waste collection will be suspended temporarily.

Four do's:

The following four key messages are very important:

Do ensure that additional non recyclable waste is placed in refuse sacks - (following a missed collection, side waste can be presented in black sacks) and put out beside the closed wheeled bin (i.e. with the bin lid firmly down) to enable safe handling by collectors

po place extra recycling materials in a suitable alternative box/bag and place it alongside normal recycling containers ready for collection when things return to normal

Do remember that you can take recyclable waste - such as tins, glass and newspapers - to bring banks around the district if you do not wish to wait for your next kerbside collection

Do make sure that your waste and recycling containers are presented at the kerbside by 7am on your collection day (unless you receive an assisted collection)

Is your community resilient enough?

ith winter fast approaching it is possible that the district may experience more heavy snow, flooding or other severe weather events.

So what can you do to lessen the effects? Over the past six years, officers at the Council have been helping and encouraging local communities to strengthen their resilience through community emergency planning. This has resulted in local communities establishing sound procedures, networks and structures that enable them to cope in a range of potential emergencies.

The Council has donated 'Battle Boxes' to many communities, providing them with essential equipment

Many communities have produced a list of resources available locally (such as snow ploughs and power generators) and the people who can use them. The success of these community emergency plans relies on resident volunteers in these communities and on clear communication links which are also very important.

To further support communities, the Council has donated 'Battle Boxes' to many communities, providing them with essential equipment, such as foil blankets and wind-up torches. This helps residents to support themselves and the most vulnerable members of their community during an emergency.

At present 23 communities in the district have community emergency plans in place and a further 10 communities are currently developing their plans.

Local Planning issues - the facts

Cllr Nick Parsons, Deputy Leader of Cotswold District Council and Cabinet Member for Forward Planning. explains why changes to the coalition government's planning policy have taken away significant decision making powers from local authorities.

> **SURELY THERE MUST BE SOME** SORT OF WAY TO OPPOSE THESE LAND GRABS RIGHT NOW?

At present nearly every planning appeal decision places a high emphasis on the government's drive to address the national housing shortage, through the requirement

> to have a five year housing land supply. This has been made even more onerous for all authorities by the government's effectively increase

the land supply requirement by between 5% to 20%. This causes a particular problem in rural areas where developers are unable - or where it would not be practicable - to build all the houses for which planning permission has been granted within a five-year period.

We have done our best to establish a five-year land supply in accordance with national guidelines, but in recent years planning inspectors have rejected our estimates at appeals and have agreed with figures put forward by developers. We are not alone - this has become a common pattern across the country with recent reports suggesting that almost 200 councils do not have a five year land supply. Close to home, the councils serving Cheltenham, Cherwell, Stratfordon-Avon, Stroud, Tewkesbury, and Wychavon have all recently lost major

planning appeals on much the same grounds as this Council.

MANY PEOPLE HAVE SAID THE GOAL POSTS HAVE BEEN **MOVED. DO YOU AGREE?**

Many local authorities - including Cotswold - were part way through a process to plan for future development only to find that the rules had changed. This led to councils across the country withdrawing or delaying the preparation of new Local Plans to reassess whether they complied with the new guidance

IS THERE A SOLUTION IN THE **LONGER TERM?**

The adoption of the Local Plan will enable us to mount a robust defence of our planning decisions - most notably on housing land supply. An evidence-based assessment of housing need, which will support the Local Plan, suggests that we need to plan for nearly 7,000 new homes in the district up to 2031 - and this may increase subject to factors outside of our control.

Although 7,000 is higher than many would have wished, our hands are tied because national policy requires all types of housing needs and demands to be taken into account, including the needs of people moving into the District. Indeed, if we don't comply with national guidance, the Local Plan will be

WHY HAVE DEVELOPERS BEEN **ABLE TO OVERRIDE DECISIONS** MADE BY THE COUNCIL'S **PLANNING COMMITTEE WHICH WERE FULLY SUPPORTED BY** LOCAL RESIDENTS?

Like many local authorities across the country, this Council has had its decisions overturned at major planning appeals, even when the vast majority of local residents have been opposed to the developments being proposed.

This is because the government has introduced new national legislation which places emphasis on increased housing numbers regardless of local opinion - or environmental factors - when planning inspectors feel that there is insufficient supply of land for housing needs over a five-year period.

rejected by the Secretary of State and we will be back to square one.

On the plus side, some 2,550 houses have already been built, or permitted since April 2011, which leaves a further requirement for about 4.500 houses over the next 18 years to 2031.

Additionally, we have switched to a much quicker means of producing a comprehensive Local Plan for the district, covering the next 20 years or so, which will shave some two years off the process.

WHAT ABOUT LOCALISM?

The government said that scrapping regional plans would see the end of 'top down' planning being imposed

on communities. However, in reality, the new national policy means that we are faced with a requirement for more houses than previously envisaged.

About three-quarters of the district falls within the Area of **Outstanding Natural** Beauty (AONB)

It seems that 'localism' will only allow neighbourhoods to plan for more housing, not less. We recognise that locals want to have a say on development in their communities. However, the land supply requirement has become the government's overriding, top-down consideration in planning decisions, often in spite of the wishes of local residents.

HOW DO YOU ANSWER CRITICS WHO SAY THAT COTSWOLD DC IS JUST ENGAGING IN 'NOT IN MY BACK YARD-ISM'?

About three-quarters of the district falls within the Area of Outstanding Natural Beauty (AONB), which is an important - though not overriding constraint on development. Indeed, most of the larger towns and villages lie within, or adjoin, the AONB, so it is a major challenge to find suitable development sites to meet the future housing and employment needs of the District.

Our record on house building shows that we are not a NIMBY authority. Since 2011, for example, 931 houses were built, which exceeded the annual target by 35%. We also delivered 194 affordable homes during 2012-13, which was almost double our target of 100.

This Council recognises that, regardless of the District's undoubted heritage and landscape constraints, we need to encourage young people and families to stay in the Cotswolds. otherwise communities will die. We need more younger residents to ensure that the local economy thrives and the District continues to be a pleasant place in which to live, work and visit.

Local Plan – progress update

- We've conducted a successful consultation for the Local Plan: Preferred Development Strategy, and received over 2,000 comments from 667 individuals and organisations.
- These responses will be made public when all the comments have been considered by our Forward Planning team.
- We conducted a successful call for sites for potential housing, employment and commercial development land, receiving over 200 submissions.
- The sites are being assessed, and this will feed into the site-specific work for the Local Plan.
- We are planning an independently facilitated training event for parish and town councils soon, which will start a process of working with communities to take forward site allocations.

NEXT STEPS

Feedback from previous consultations. planned community workshops, and any updated evidence will be used to

draft the Local Plan document, which will go through a further two rounds of consultation before being submitted to the Secretary of State and Planning Inspectorate for examination.

OUR TOP FIVE

Ways in which we provide a better deal for the community

We are working towards our aim of being recognised as the most efficient council in the country. Here are our five of our achievements against our Medium Term Financial Plan. Cotswold District Council leader Cllr Lynden Stowe reviews recent achievements.

he savings we have generated have played a major part in protecting our provision of services to residents at a time of significantly reduced central government funding. This has allowed us to freeze many of our charges over the last two years including Council Tax, Garden Waste, Car Parking and Leisure, and has also helped to fund the 5% cut we made to our share of this year's Council Tax bill – the biggest reduction in the country.

JOINT WORKING WITH OTHER COUNCILS

• We have been looking for ways to save money by sharing staff and services across neighbouring councils, especially West Oxfordshire District Council. Joint working between the two councils has resulted in savings of about £1.7 million per year while maintaining the quality of services to residents.

In total, there are plans for us to save up to £3 million per year by introducing further joint working and we are confident that we can achieve this target while maintaining all our frontline customer services.

As part of this achievement, we have successfully brought together the personnel, finance, procurement and payroll functions for this Council, Cheltenham

Borough Council, Forest of Dean District Council, West Oxfordshire District Council and Ubico Ltd

Our savings have allowed us to freeze many of our charges

under one umbrella organisation known as GO (Gloucestershire-Oxfordshire.) This represents an annual cost saving of £125,000 for this Council alone and almost £700,000 jointly for all the partners.

INTRODUCING FORTNIGHTLY KERBSIDE COLLECTION OF RIGID PLASTICS

For the first time ever, residents can now recycle rigid plastics at their kerbside. Ubico Ltd – which was established jointly by this Council





and Cheltenham Borough Council
– introduced the new service across
the district just over a year ago,
thanks to the use of more efficient
recycling vehicles.

This has contributed to our continuing high levels of recycling in the district – residents recycle about 60% of waste collected.

Setting up Ubico Ltd to provide our waste services has saved us over £850,000 in the first year compared with our previous arrangement – another significant cost saving.

COMPLETION OF FLOOD ALLEVIATION SCHEMES

We are committed to help improve resilience in our communities, including protection against flooding. Major flood alleviation improvements have now been completed at Chipping Campden, Lower Slaughter, and Weston sub Edge. Other flood relief schemes are underway, including at Moreton-in-Marsh, Lechlade and Fairford. We have secured additional County Council funding of £250,000 to support this work.

COTSWOLD LEISURE AND **CORINIUM MUSEUM TRANSFER** TO 'EVERYONE ACTIVE'

We have transferred the management of our leisure centres at Bourton, Cirencester and Chipping Campden and the multi award-winning Corinium Museum to 'Everyone Active'. This should save about £3 million over 10 years whilst maintaining the excellent levels of service. The public can rest assured that the

Council will retain ownership of the buildings and assets and will manage the contract with 'Everyone Active' closely.

PROVIDING AFFORDABLE HOMES.

■ We helped to deliver 194 affordable homes for local people during 2012-13 - almost double our target of 100. This included new affordable homes in Cirencester (Kingshill North and South), Andoversford and Longborough.

These homes will help to meet the needs of different groups, including older people and those living in rural areas. For the record, over 300 affordable new homes were built in the District between 2005 and 2011.
